## Kit specificity:


This assay kit contains antibodies which recognize distinct epitopes on TFEB. The protein detected by this kit corresponds to UniProt ID P19484. TFEB is also known as TCFEB and transcription factor EB. These antibodies recognize TFEB of human origin. Other species should be tested on a case-by-case basis.

### **Control lysate information:**


Positive Control Lysate: Prepared from A431 cells, cultured to confluency in T175 flasks in 10% FBS containing medium and lysed with 10 mL of Lysis Buffer.

### **Representative data**

Data obtained with a 2-plate, 2-incubation protocol. A431 cells were plated at 60K cells/well in a 96 well plate and incubated overnight. Cells were treated with Torin1 at the indicated concentrations for 3 hours. Cells were lysed with Lysis Buffer and assayed separately for Phospho (Ser122 and Ser211) and Total TFEB using respective *SureFire Ultra* kits. Equivalent to approximately 4,000 cells/datapoint.



Data obtained with a 2-plate, 2-incubation protocol. HepG2 cells were plated at 40K cells/well in a 96 well plate and incubated overnight. Cells were treated with Torin1 at the indicated concentrations for 3 hours. Cells were lysed with Lysis Buffer and assayed separately for Phospho (Ser122 and Ser211) and Total TFEB using respective *SureFire Ultra* kits. Equivalent to approximately 2,600 cells/datapoint.
