## Kit specificity:


This assay kit contains antibodies which recognize phospho-Thr567, phospho-Thr564 and phospho-Thr558 epitopes and distal epitopes on Ezrin, Radixin and Moesin respectively. The proteins detected by this kit correspond to UniProt IDs P15311 (Ezrin), P35241 (Radixin) and P26038 (Moesin). These antibodies recognize Ezrin/Radixin/Moesin of human and mouse origin. Other species should be tested on a case-by-case basis.

## **Control lysate information:**


Positive Control Lysate: Prepared from HeLa cells cultured to confluence in T175 flasks in 10% FBS containing medium and lysed with 6 mL of Lysis Buffer.

## Representative data:


Data obtained by a 2-plate, 2-incubation protocol. HeLa cells were seeded at 40K cells/well in a 96-well plate and incubated overnight. Cells were treated with Calyculin A at the indicated concentrations for 1 hour. Cells were lysed with Lysis Buffer and assayed separately for Phospho Ezrin (Thr567)/Radixin (Thr564)/Moesin (Thr558) and Total Ezrin/Moesin levels using respective *SureFire Ultra* kits. Equivalent to approximately 200 cells/datapoint.



Data obtained by a 2-plate, 2-incubation protocol. A549 cells were seeded at 40K cells/well in a 96-well plate and incubated overnight. Cells were treated with Staurosporine at the indicated concentrations for 1 hour. Cells were lysed with Lysis Buffer and assayed separately for Phospho Ezrin (Thr567)/Radixin (Thr564)/Moesin (Thr558) and Total Ezrin/Moesin levels using respective *SureFire Ultra* kits. Equivalent to approximately 1,000 cells/datapoint.



Human and mouse cell lysates were diluted with Lysis Buffer to represent approximately 10,000 cells/datapoint. Phospho Ezrin (Thr567)/Radixin (Thr564)/Moesin (Thr558) were evaluated using the *SureFire Ultra* kit.
