<b>ISOTHIAZOLINONES, MIXED</b>	<p>The following information refers to contact allergens as a group and may not be specific to this product. Contact allergies quickly manifest themselves as contact eczema, more rarely as urticaria or Quincke's oedema. The pathogenesis of contact eczema involves a cell-mediated (T lymphocytes) immune reaction of the delayed type. Other allergic skin reactions, e.g. contact urticaria, involve antibody-mediated immune reactions.</p> <p>In light of potential adverse effects, and to ensure a harmonised risk assessment and management, the EU regulatory framework for biocides has been established with the objective of ensuring a high level of protection of human and animal health and the environment. To this aim, it is required that risk assessment of biocidal products is carried out before they can be placed on the market. <b>P-TERT-OCTYLPHENOL ETHOXYLATE</b>	<p>Octoxynols:</p> <p>Octoxynols of various chain lengths as well as octoxynol salts and organic acids function in cosmetics either as surfactants-emulsifying agents, surfactants-cleansing agents, surfactant-solubilizing agents, or surfactants-hydrotropes in a wide variety of cosmetic products at concentrations ranging from 0.0008% to 25%, with most less than 5.0%. The octoxynols are chemically similar to nonoxynols.
